



## SELECTION CRITERIA

### 1. OBJECTIVE

The purpose of this document is to set out the criteria that will be used by the IMC Working Group (IMC WG) to select athletes for the above competition. The objective of the document is to select the most competitive team to represent Kenya.

### 2. SWIMMERS SELECTION CRITERIA

(i) Any swimmer that has achieved a FINA “A” or “B” qualifying time will be automatically selected to the team, provided however, that the “A” or “B” time is achieved within the qualifying period and prior to the entry deadline set by the organizers. (ii) If no FINA “A” or “B” qualifying times have been achieved, or there are available places in the team after other swimmers achieved FINA “A” or “B” qualifying times, the following is the selection parameters:

<b>Min FINA points</b>	<b>550 FINA Points</b>

<b>Selection Pool Course</b>	Long Course Times Only
<b>Selection Period</b>	01/01/2021 - 13/06/2022*
<b>Events Available per Swimmer</b>	TBC
<b>Swimmers Permitted per Event</b>	Two swimmers per event

\*Selection period corresponds to the set dates of the competition. These may be amended in the event of a change in the competition dates.

(iii) A swimmer must demonstrate competitive readiness to be eligible for the selection and must remain competitively ready throughout the period leading up to the competition.

(iv) The number of individual events will be based on the organizers' rules on events availability to the swimmers and maximum swimmers allowed per event per nation. The selection of the individual events for a swimmer shall depend on the swimmer's qualifying events and shall be at the discretion of the Technical Committee IMC WG.

The IMC WG reserves the right to exercise its discretion to form the team, or part of the team, in special circumstances that do not meet the criteria set in the selection policy document. In this event such decision(s) shall be made by IMC WG or a panel appointed by IMC WG for the purpose, with rationale, reasons for the decision(s) and the decision itself minuted and submitted to IMC WG.

### 3. SWIMMER ELIGIBILITY

(i) A Swimmer must be able to represent Kenya in accordance with the eligibility requirement rules set out by FINA and on the first day of the competition must hold a Kenyan passport which expires no earlier than December 31, 2022.

(ii) A swimmer must declare and commit to availability to participate at select qualification events and other team events including but not exclusively staging camps, targeted preliminary competitions, anti-doping education sessions, anti-doping testing, strength and conditioning training, nutrition, physiotherapy, and mental skills training as are determined by the IMC WG in consultation with sports experts.

(iii) A swimmer must commit and undertake to provide periodic reports as may be set by the IMC WG.



(iv) A swimmer must commit to follow all the guidelines and protocols as may be set by the organizers, government or other relevant authorities. Swimmer must be willing to comply with and sign any agreement and waivers as it relates to the prevention of the spread of Covid 19 including but not exclusive to the requirement to undergo Covid 19 testing and or vaccination requirements.

#### 4. COMPETITIVE READINESS

(i) “Competitive readiness” is the confirmation of the athlete’s being in active training and is defined as the ability of the athlete to achieve equal or superior performance(s) at the scheduled event, as compared to the performance(s) the athlete achieved prior to the competition.

(ii) Athletes must submit the attached fully completed Competitive Readiness Form (signed by both athlete/guardian and coach) within such time as may be provided by the IMC WG to be eligible for selection, *see Appendix 1*.

(iii) Athletes who do not demonstrate competitive readiness by reason of lack of fitness, injury, or illness may be removed from the team. Athletes and their personal coaches are required to immediately report any injury, illness or change in training that could affect their ability to compete at their highest level at the competition to the IMC WG in writing via email ([competitions@kenyaswimmingfederation.org](mailto:competitions@kenyaswimmingfederation.org));

(iv) The final decision on competitive readiness will be made in concert with the swimmers’ coach, the IMC WG, designated team physician, therapist or such other professional who may have knowledge of the swimmer’s specific circumstances and/or an expert in sports injuries.

#### 5. TEAM OFFICIALS SELECTION CRITERIA - COACH

Where possible gender balance must be observed when selecting team officials. At a minimum, there must be one female team official if there is at least one female athlete in the team.

To be eligible for selection, the applicant:

- (i) Must be a registered coach and member in good standing;
- (ii) Prior experience of having placed a swimmer(s) on the National team is an added advantage;
- (iii) Must apply within the allocated deadline by submitting a fully completed form and providing all the necessary attachments, *see Appendix 2*.
- (iv) Must hold a valid passport, which expires no earlier than December 31, 2022;
- (v) Must not have past, current or pending disciplinary action taken against her/him on matters of conduct regarding management of athletes or such other action; and
- (vi) Must sign the Code of Conduct and the Duties and Responsibilities of Team Official on or before the set deadline of 15th July 2022 - 12:00am and provide any other documents as may be set by IMC WG or the organisers;

The IMC WG reserves the right to exercise its discretion to appoint coach(es) should there be no applicants, or should applicants not meet the set criteria parameters;

The IMC WG reserves the right to exercise its discretion to appoint personal coaches of swimmers selected on the national team, subject to restrictions and the swimmer/officials ratio as set by the organizers.

Only successful candidates will be contacted.

## 6. TEAM OFFICIALS SELECTION CRITERIA - OTHER ROLES

Where possible gender balance must be observed when selecting team officials. At a minimum, there must be one female team official if there is at least one female athlete in the team.

To be eligible for selection, the applicant:

- (i) Prior experience of having a role in the national team is an added advantage;
- (ii) Must apply within the allocated deadline by submitting a fully completed form and providing all the necessary attachments, *see Appendix 2*.
- (iii) Must hold a valid passport, which expires no earlier than December 31, 2022;
- iv) Must have a good understanding and technical know-how of the sport and/or be a subject matter expert.
- (v) Must have good and demonstrable administrative or other professional skills and experience.
- (vi) Must have a current licence of the licensing authority for her/his area of expertise, if her/his profession requires such licence.
- (vii) Must not have past, current or pending disciplinary action taken against her/him on matters of conduct regarding management of athletes or such other action; and
- (viii) Must sign the Code of Conduct and the Duties and Responsibilities of Team Official on or before the set deadline of 15th July 2022 - 12:00am and provide any other documents as may be set by IMC WG or the organisers;

The IMC WG reserves the right to exercise its discretion to appoint team official(s) should there be no applicants, or should applicants not meet the set criteria parameters;

Only successful candidates will be contacted.

## **7. REMOVAL OF SWIMMER**

(i) The IMC WG may, at any time, disqualify an athlete from being considered for selection to the Kenya Team, or remove an athlete after the selection, based on current or past behaviour of the athlete that is inconsistent with KSF's Team Rules, Regulations and Code of Conduct.

(ii) An athlete will be removed from being considered for selection to the Kenya Team or removed after selection if he/she is found to be in violation of any anti-doping policy or



procedure as outlined by Anti-Doping Agency of Kenya, FINA and World Anti-Doping Agency (WADA).

## 8. UNFORESEEN CIRCUMSTANCES

(i) Should the IMC WG determine that unforeseen or unusual circumstances have arisen during the process of applying these criteria, the IMC WG shall have the full and absolute discretion to resolve the matter as it sees fit, considering factors and circumstances that it deems relevant, fair and appropriate.

(ii) Any such exercise of discretion shall be subject to the principles of fairness and good sportsmanship.

## 9. APPEAL PROCESS

Selection results from the IMC WG selection will be made available through public means and will be published on the KSF website, on completion of the selection process.

Appeal against non-selection by IMC WG must be made in writing within 2 days (48 hours) of the public announcement of the athletes selected for the competition, via email to [competitions@kenyaswimmingfederation.org](mailto:competitions@kenyaswimmingfederation.org)

The grounds for any appeal shall be:

(i) The athlete's omission was a result of a failure by the IMC WG to properly apply the eligibility and selection criteria set out in this policy;

(ii) The athlete's omission was a result of a failure by the IMC WG to adhere to the terms set out in this selection criteria; and

(iii) The athlete's omission was a result of failure by the IMC WG to take into account particular relevant information submitted prior to the selection deadline.

The IMC WG shall consider and deliberate the appeal and, if deemed justifiable, will hear the appeal by the athlete concerned and provide the final decision within 72 hours of receipt of the Appeal. Any further appeal shall lie with the Sports Disputes Tribunal.

The IMC WG shall have the full and absolute discretion for selection of the team coach(es) and team officials.



The Working Group reserves the right to amend this criteria and the amended criteria will be recirculated and published on the KSF website.

## **Appendix 1**

### **COMPETITION READINESS REPORTING FORM**

#### **Preamble:**

This form is to be completed by all athletes who are aspiring to be considered for selections into the national team for various competitions. This form is to be filled in by each swimmer age 18 years old and above, or by a guardian for swimmers age under 18 years old, and by the swimmer's coach, in relevant parts.

While every selection will follow specific criteria, in exceptional circumstances the selectors may exercise their discretion as stated in the criteria document. Competitive readiness is the requirement for all athletes potentially eligible for selections. The feedback through this form shall form part of training and wellbeing monitoring of athletes, and their competitive readiness for consideration for various selections. KSF/IMC-WG may from time to time require athletes/guardians and coaches to return this form by a set deadline. Only athletes that demonstrate continued training and preparation for competitions shall be considered at the team selection stages.

Information provided is subject to further verification as deemed necessary. Any information that is misleading, inaccurate or false will lead to an automatic removal of the athlete from being potentially considered, subject to particular criteria, or to removal from the team if already selected, and may lead to further disciplinary measures.

Completed form must be returned on or before such dates as shall be established by the IMC-WG on behalf of KSF. Completed form should be returned via email to:
